Terms and Conditions

1. Details of the promotion

1.1 Information on how to enter the Ballina Fair “Win a VIP Breakfast Experience with Santa” (“Promotion”) and the prize details form part of these Terms and Conditions. Participation in the Promotion is deemed acceptance of these Terms and Conditions.

1.2 The promoter of this Promotion is Ballina Fair Shopping Centre of 84 Kerr Street Ballina NSW 2478 Telephone: 02 66 868555 (ABN 34 430 406 448) (“Promoter”).

1.3 Entry is only open to Australian residents. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion. Employees (and their immediate families) of the Promoter, employees of any store in Ballina Fair and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

1.4 This Competition is being run at Ballina Fair Shopping Centre ONLY.

1.5 The Promotion will commence at 8am (local time) on 1st December 2018 and ends at close of trade on Thursday 20th December (“Promotional Period”). The Prize must be taken on Sunday 23rd December from 8.30am till 10am only.

1.6 Customers are given an entry form once they have paid for their Santa Photos at Ballina Fair. All required information and contact details must be stated clearly on the entry form.

1.7. To enter the WIN A VIP BREAKFAST EXPERIENCE WITH SANTA, entrants must complete the entry form and entries must be received by the Promoter by the close of business on the specified closing date.

1.8. Prize winners of the Ballina Fair WIN A VIP BREAKFAST EXPERIENCE WITH SANTA competition will be selected at Ballina Fair Centre Management, 84 Kerr Street, Ballina NSW 2478 on Friday 21st December at 10am AEST. Winners are contacted by phone or mail within 1 business day of selection and will be announced on the Centre’s website at www.ballinafairshopping.com.au. The winner of the Prize will be notified by mail or email and telephone.

1.9. The judges’ decision is final and binding. As such, no correspondence will be entered into.

2. Prize

2.1 The prize consists of a VIP Experience with Santa at The Coffee Club Ballina Fair 8:30am to 10:00 am with Santa. Table to accommodate up to 8 guests (4 adults and 4 children) Meet & Greet with Santa at your table. Includes Full Breakfast and Drinks for 8 People valued at \$500.

2.2 A draw for any unclaimed prizes at a Participating Centre may take place on 5 December 2016 at the same time and place as the original draws at Centre Management Ballina Fair Shopping Centre, 84 Kerr Street Ballina NSW 2478, subject to any directions from a regulatory authority. Winners will be notified by email and phone within 2 days of the draw.

2.3 Subject to the unclaimed prize draw clause, if for any reason a winner does not take a prize by the time stipulated by the Promoter, then the prize will be forfeited.

or third party interference; (c) any membership application or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter;
